



We are experiencing increased custom inspections of HHG shipments while transiting through Belorussian - Russian border points. Belorussia is the gateway for road and rail transportation between EU, Russia ,Kazakhstan and The Central Asian Republics. As a member of Eurasian Customs Union, Belorussian customs has a legal right to inspect all transit shipments regardless of final destination of the shipment in the CIS territory. Our recent experiences show that general description of packed items on the packing list in not accepted by the Belorussian customs and triggers

vigorous customs inspection of the shipments. We have also noticed similar trend in Russia where customs is also taking extra interest in the content of HHG shipments moving to the CIS.

In order to avoid border custom inspections and consequential confiscation of undeclared goods or penalties, we highly recommend to follow below

In order to avoid border custom inspections and consequential confiscation of undeclared goods or penalties, we highly recommend to follow below instructions.


- 1. Please do not pack prohibited items (new items, alcohol, medicines without prescriptions, drugs, food items, materials containing terroristic information, weapons, etc). In case there are still new items, please make sure to remove original packaging or price tags. Only 3 liters of alcohol is allowed, make sure to put beverage name and description. Medicines must be listed in the inventory and packed with prescriptions.
- 2. Do not allow undeclared goods in the Packing list. Avoid inserting general description of packed items on the packing list, such as Kitchenware, Clothes, Bedroom items, PBO, Miscellaneous, etc.
- 3. Please mention exact name or description of the item and quantities on the packing list, such as 12 Water Glasses, 5 T-shirts, 1 Guitar, 10 Books, etc.
- 4. Electronic items please put technical description, name and model. Some electronic appliances are prohibited/restricted or require special permission, so please check with us in advance prior to pack out of the shipment.
- 5. Please mention exact quantity of items on the packing list.
- 6. Please mention exact gross weight of each individual carton on the packing list.

We do realize it will be an extra work for your packing crew and/or origin agents to provide our recommended information on the packing lists but we can assure you that by doing so, you will avoid a lot of hassles, save cost and time in case of any custom inspection on border points.


